Notice is also given that the filing deadlines for such offices are February 15, 2024, at 5:00 p.m. for incumbents and March 1, 2024 at 5:00 p.m. for non-incumbents. An incumbent is anyone serving in an elective office; even if they are filing for an office other than the one in which they are presently serving, they are required to file by 5:00 p.m. on February 15, 2024.
