

BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

May 13, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on May 13, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Dean, seconded by Fritsche, to approve the following items on the consent agenda: 1) minutes from the Previous Board of Commissioners meeting, 2) accounts payable claims in the amount of \$ 340,465.93, 3) Resolution No. 1514, Book 24, Page 21, Directing Road Superintendent to Conduct Study of Road 724 Between Roads 389 and 390, and Make Recommendations as to Vacation or Abandonment of Said Road, 4) reappoint Matt Springer and Dr. Jason Blomstedt to Health Board, terms to expire April 30, 2027, 5) Oversized Load Permit for Rose Weskamp, 6) County Road Occupancy Agreement with Viaero Fiber Networks, LLC, 7) Special Liquor License for Roundup Indianola, 8) Special Liquor License for Tidy's Sip & Seed, LLC, 9) County Road Occupancy Agreement with Quality Irrigation, 10) letter of support for the Western Republican River Basin Riparian Habitat Improvement Project.
