BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS July 8, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on July 8, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. No one was present.

Chairman Gans recessed the Commissioners' meeting at 9:17 a.m. for the Board of Equalization. BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:17 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Linda Parde, Deputy Treasurer, presented a motor vehicle exemption application from Community Hospital for a 2024 Toyota Rav4. A motion was made by Gans, seconded by Fritsche, to approve the motor vehicle exemption application from Community Hospital 2024 Toyota Rav4. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:20 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:20 a.m.

The Board reviewed a recommendation from the Planning & Zoning Board. The P&Z Board held a public hearing Monday, June 24, 2024, regarding the closure of Road 724 between Roads 389 and 390. They recommend that the County close the road to public traffic.

A motion was made by Dean, seconded by Fritsche, to approve Resolution No 1519 to hold a public hearing at 9:30 a.m. on August 12, 2024, regarding the closure of Road 724 between Roads 389 and 390. Roll Call: Ayes: Gans, Dean, Fritsche.

Barry Williams and Travis Radnor (via zoom) with Great Plains Communications joined the Board to request a letter of support for a project that involves over 60 customers lacking broadband service. Great Plains uses State funding to build out rural areas. The applications to receive those funds are due to the Public Service Commission by July 15, 2024. They are asking the County to waive the usual fees, with Great Plains fixing any road disturbance.

A motion was made by Dean, seconded by Fritsche, to provide a letter of support for the project. Roll call: Ayes: Gans, Dean, Fritsche.

Jordan Garner with Murphy Tractor joined the Board to present information about a piece of equipment called a Retriever. It attaches to a motor grader, breaks up chunks of soil and deposits them in the center of the road. Garner would also like to set up a demo of a new motor grader at some point soon.

Sheriff Kevin Darling joined the Board to review a letter from Bill Huey with Prochaska & Associates regarding repairs to the Law Enforcement Center. Darling also presented prices from area jails to hold prisoners while repairs are being made. Darling and Dean will present schedules and numbers July 22, 2024.

The Board reviewed a quote from UniFirst for First Aid Kits for County facilities. There are some first aid kits scattered throughout the buildings, but there isn't anyone local who can service them. The Board decided to have each department head stock the current first aid kits.

The Board worked on the budget and discussed how to disperse the remaining ARPA funds.

A motion was made by Dean, seconded by Fritsche, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$429,814.32, 3) Surplus Dishwasher for Red Willow County Corrections, 4) Bailiff Interlocal Agreement, 5) Agreement with McCook Humane Society, 6) County Roadway Occupancy Agreement for Cambridge Telephone Company, 7) Liquor License for HoJo's Hideaway.
