## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

August 12, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on August 12, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:05 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. Billie Cole was present to give the Board an update on the Household Hazardous Waste program. Chris Schaffert with Adam Marshall Auctions joined the Board to report on the equipment from HHW that needs to be surplused.

Chairman Gans recessed the Commissioners' meeting at 9:15 a.m. for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

The Board reviewed a Property Valuation Protest from Buckley Haag.

Assessor Kristi Korell recommended that the size be reduced and a drying floor added.

A motion was made by Gans, seconded by Fritsche, to concur with the Assessor's recommendation. Roll Call: Ayes: Gans, Dean, Fritsche.

Treasurer Crystal Dack presented motor vehicle tax exemption applications from Community Hospital for two 2024 Toyotas and a 2024 Ford.

A motion was made by Gans, seconded by Fritsche, to approve the motor vehicle tax exemption application from Community Hospital for three new vehicles. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:20 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:20 a.m.

A motion was made by Dean, seconded by Fritsche, to enter a public hearing at 9:30 a.m. regarding the closure of Road 724 between Roads 389 and 390. The County Road Superintendent observed traffic on the road and the Planning & Zoning Board recommended that the County close the road to public traffic.

A motion was made by Fritsche, seconded by Dean, to close the public hearing at 9:40 a.m. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to approve Resolution No. 1521, Book 24, Page 28, to vacate Road 724 between Sections 12 and 13, Township 4 North, Range 29 West, of the 6<sup>th</sup> P.M., Red Willow County, Nebraska, between the East right-of-way line of Road 389 to the west right-of-way line of Road 390, and reverting the right-of-way to abutting landowners, and reserving a permanent utility easement for the full width of vacated right-of-way. Roll Call: Ayes: Gans, Dean, Fritsche.

Treasurer Crystal Dack presented collected and uncollected distress warrants. 55 warrants were issued October 31, 2023, and the Sheriff was able to collect on 43.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$335,163.72, 3) Ball & Son Movers Permit to Move Oversized Loads on County Roads, 4) Proposal from Domestic Abuse Sexual Assault Services, 5) Interlocal Agreement for Housing Inmates in Lincoln County.
