## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS September 23, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on September 23, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. No one was present.

Chairman Gans recessed the Commissioners' meeting at 9:15 a.m. for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Lori Stevens, Deputy Assessor, presented a contract with Pritchard & Abbott for the Board's approval. Prichard & Abbott does the valuation of oil wells. It is a two-year contract with an increase of around \$400.00.

A motion was made by Gans, seconded by Fritsche, to approve the contract with Pritchard & Abbott as presented. Roll Call: Ayes: Gans, Dean, Fritsche.

Stevens also presented three tax roll corrections for 2023: No. 10 which decreased the tax rolls by \$956.18, and No. 11 which decreased the tax rolls by \$62.78, No. 12 which decreased the tax rolls by \$39.08.

A motion was made by Gans, seconded by Fritsche, to approve the tax roll corrections as presented. Roll Call: Ayes: Gans, Dean, Fritsche.

Linda Parde, Deputy Treasurer, presented Resolution No. 1541, Book 24, Page 48 to Strike Personal Property Tax for Mobile Home on Leased Land for a decrease of \$50.95.

A motion was made by Gans, seconded by Fritsche, to approve Resolution No. 1541, Book 24, Page 48 as presented. Roll Call: Ayes: Gans, Dean, Fritsche.

Parde also updated the Board on delinquent taxes. A motion was made by Fritsche, seconded by Gans, to acknowledge the update. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:35 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:35 a.m.

A motion was made by Fritsche, seconded by Dean, to enter a public hearing for budget approval at 9:35 a.m. Roll Call: Ayes: Gans, Dean, Fritsche.

Dan Miller, CPA, was present with copies of the proposed budget. Miller explained the proposed numbers in detail.

A motion was made by Dean, seconded by Fritsche, to adjourn the public hearing at 10:05 a.m. and enter a special hearing to set the final tax request. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to adjourn the special hearing to set the tax request. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to Increase the Base of Restricted Funds by an Additional 1%. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1536, Book 24, Page 43 to Adopt 2024/2025 Budget as presented. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to adopt Resolution No. 1537, Book 24, Page 44 to Set the Final Tax Request at an Amount Different from the Prior Fiscal Year. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Gans, seconded by Dean, to adopt Resolution No. 1538, Book 24, Page 45 to Transfer \$669,746.00 from General Fund to Road/Bridge Fund. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1539, Book 24, Page 46 to Transfer 28.9123% of General Fund Levy to Self-Insurance Fund. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to adopt Resolution No. 1540, Book 24, Page 47 to Transfer \$609,000.00 From Inheritance Fund No. 2700 to General Fund No. 0100 As Needed. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed informal quotes for a Lycox Front Mount Retriever. This piece of equipment pulls gravel from the ditches back onto the roadways. Dean obtained two quotes: NMC for \$22,730.00 and John Deere for \$24,135.00.

Fritsche said the best time to use a Retriever is in the spring. He would like to see the equipment in action before he approves the expense.

A motion was made by Dean, to accept the informal quote from NMC for the Lycox Front Mount Retriever. The motion died for lack of a second. A motion was made by Fritsche, seconded by Gans to table the issue until the October 7, 2024 meeting for further research. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$895,248.11, 3) Grant from Nebraska Department of Health and Human Services 4) Just 1 More Bar & Grill LLC Liquor License, 5) Resolution No. 1543, Book 24, Page 50 - Red Willow County's Policy on Illegal Immigrants.
