BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS March 10, 2025

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on March 10, 2025. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed and accounts payable claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Dean, seconded by Fritsche, to approve items 1 through 5 on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$208,453.48. 3) authorize Chairman's signature on Flood Plain Form 4) approve changes to Health Department's inventory 5) authorize Chairman's signature on Wardcraft Homes Oversized Load Permit. Item 6) authorize Chairman's signature on tractor lease for Fair will be postponed until the next meeting. Roll call: Ayes: Gans, Dean, Fritsche.

There were no issues for the Board of Equalization.

The Board was joined by Jiles Bowman, Fairgrounds Manager, Jo Teter, and Gale Rippe to discuss the Fair Board vacancy and appointment. As only two Board Member can live in a particular area, one must resign and be replaced. Galen Perry, last appointed, has offered to step down and allow the appointment of someone from another area. There are five interested candidates. Andrea Pennock, John O'Dea, Brandon Hoyt, Derek Meyers, Kellie Soden, Todd Thiesen. Teter said the candidates are welcome to come to a Fair Board meeting so everyone can get acquainted. Gans and Dean reiterated that the choice is up to the Board of Commissioners. Teter wanted to go on record that, in spite of over 40 years precedence, the Board of Commissioners will no longer take member recommendations from the Fair Board.

A motion was made by Dean, seconded by Gans, to appoint Derek Meyers to the Fair Board to replace Galen Perry, term to expire December 2027. Roll Call: Ayes: Gans, Dean, Fritsche.
