## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS May 27, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on May 27, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:35 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

Chairman Gans recessed the Board of Commissioners meeting for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Crystal Dack, Treasurer, presented tax roll correction No. 10 for 2025 for accelerated personal property due to a business closure with an increase of \$232.76.

A motion was made by Gans, seconded by Fritsche, to approve the tax roll correction as presented. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:18 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:18 a.m.

Serge Yeboa, Jail Administrator, joined the Board to discuss increases in fees from Consolidated Food Management. Yeboa has been communicating with Consolidated about the difference in quoted and billed fees. Consolidated has offered a fee schedule of \$270.00 per day, plus \$1.10 per meal. That would equal around \$10,000 per month. Yeboa is going to propose a daily meal fee rather than a per meal rate. He will report his findings to the Board.

Carol Schlegel, Tourism Director, presented her Quarterly Report. The Visitors' Bureau is involved in many upcoming events, including Tour de Nebraska, National Versatility Ranch Association, Noel on Norris and Bash on the Bricks.

The Board reviewed a letter from the Bridge of Hope requesting support for fiscal year 2025/2026. A motion was made by Dean, seconded by Fritsche, to continue supporting Bridge of Hope in the amount of \$4,500 for the FY 25/26. Roll call: Ayes: Gans, Dean, Fritsche.

The following correspondence was reviewed and placed on file: 1) Nebraska Department of Transportation – Update on Road Project NH-83-1(123) from Kansas State Line, Continuing Seven (7) Miles North, 2) Tax Equalization and Review Commission – Values of Property in Red Willow County Meet the Requirements of Law.

The Sheriff's Monthly Revenue Report was reviewed and placed on file.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$467,430.28, 3) reappoint James Coady to Planning Commission, term to expire April 30, 2027, 4) extend Mike Daffer's term through June 5, 2025, then find
