## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS August 11, 2025

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on August 11, 2025. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$244,834.73, 3) appoint MIPS to Provide JPH Postcards, 4) Applied Connective quote for Cyber Security services. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans recessed the Board of Commissioners meeting for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:18 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Crystal Dack, Treasurer, presented a motor vehicle exemption application from Community Hospital for a 2025 Toyota Rav4. A motion was made by Gans, seconded by Fritsche, to approve the motor vehicle exemption application from Community Hospital for a 2025 Toyota Rav4. Roll Call: Ayes: Gans, Dean, Fritsche.

Dack also presented a tax roll correction for 2025. A motion was made by Gans, seconded by Fritsche, to approve Tax Roll Correction No. 11 which increased the tax rolls by \$5,630.22. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:24 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:24 a.m.

Dack rejoined the Board to present a report of collected and uncollected distress warrants. There were 59 distress warrants issued on November 1, 2024, for a total of \$146,068.91. There were 43 distress warrants collected in the amount of \$36,656.91, and there were 16 distress warrants returned uncollected by the sheriff in the amount of \$128,576.17.

The Board discussed hiring a Flood Plain Manager. A motion was made by Dean, seconded by Fritsche, to hire Miller & Associates as the County Flood Manager for \$100.00 per hour, as needed. Roll Call: Gans, Dean, Fritsche.

Dan Miller, CPA, joined the Board to discuss preliminary budget numbers. The Board will meet with him again Tuesday, August 19, 2025, after the Assessor has determined the growth values.

The following correspondence was reviewed and placed on file: 1) FEMA – Federal Funds Available for Disaster Relief, 2) Nebraska Department of Water, Energy & Environment – Issued Permit Transfer to Hauxwell Land & Cattle.
