BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS October 27, 2025

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on October 27, 2025. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

Gans recessed the meeting at 9:12 a.m. for the Board of Equalization.

Chairman Dean called the Board of Equalization to order at 9:12 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Crystal Dack, Treasurer, presented Resolution No. 1582, Book 24, Page 89 to strike taxes and Resolution No. 1583 Book 24, Page 90 to direct County Attorney to commence foreclosure proceedings on certificate no. 182022.

The first is on two mobile homes that have been torn down. The second is on 2024 property taxes. A motion was made by Gans, seconded by Fritsche, to approve Resolution Nos. 1582 and 1583. Roll Call: Ayes: Gans, Dean, Fritsche. Dean adjourned the Board of Equalization at 9:22 a.m. BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:22 a.m. A motion was made by Dean, seconded by Fritsche, to recess the regular meeting and enter into a public hearing at 9:30 a.m. to receive public comments on the One and Six-Year Road Plan. Roll Call: Ayes: Gans, Dean, Fritsche.

Kevin Petross with Miller & Associates joined the Board via phone as they reviewed a map of the bridges and culverts addressed in the plan. There are three locations on the map. There was some discussion about the various issues on the plan.

A motion was made by Fritsche, seconded by Dean, to adjourn the public hearing at 9:37 a.m. and reconvene the regular meeting. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1581, Book 24, Page 88 to Adopt the 2025 One and Six-Year Road Plan as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed the fiscal year 2024-2025 Audit Report. The only finding was a problem with distress warrants.

A motion was made by Dean, seconded by Fritsche, to respond to the Auditor that the distress warrants will be collected upon this November. Roll Call: Ayes: Gans, Dean, Fritsche.

The Board also discussed the elected Official's salaries for the 2027-2030 term of office. They reviewed a salary study prepared by NACO, which took into consideration county population, valuation, and many other variances.

A motion was made by Dean, seconded by Fritsche, to direct the Clerk to prepare a resolution for a 2.5% increase over the officials' term of office, to be considered next meeting. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to approve three Roadway Occupancy Permits for McCook Public Power District pending payment. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to table the payment for tower rental fee until the contract can be reviewed. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to approve the remaining items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$599,682.66, 4) surplus Laptop for Extension Office, 5) Law Enforcement Agreement with City of Indianola, 6) surplus desk for County Court, 7) surplus 2017 Dodge Durango for the Sheriff, to be replaced by a 2024 Dodge Durango. Roll call: Ayes: Gans, Dean, Fritsche.
