BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

January 12, 2026

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on January 12, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$200,848.41, 3) reappoint Mike Eklund and Mike Skolout to Hillcrest Board, terms to expire December 31, 2031, 4) surplus two Gooseneck trailers for Visitors Bureau, 5) set January 26, 2026, at 9:30 a.m. as the time and date to hold a Public Hearing to amend the budget, 6) surplus trailer ramps, 2000 Kenworth truck, tip-out trash bin, 1984 Vulcan step-deck semi-trailer, barrel cart and 2006 H&H trailer for Waste and 2006 belly-dump trailer and 1955 tilt trailer for District 3. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans recessed the Commissioners' meeting at 9:10 a.m. for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Dean adjourned the Board of Equalization meeting at 9:18 a.m.

A motion was made by Dean, seconded by Gans, to re-elect Charles Fritsche as Chairman of Noxious Weed Control Authority. Roll call: Ayes: Gans, Dean. Abstain: Fritsche.

A motion was made by Gans, seconded by Fritsche, to re-elect Randy Dean as Vice Chairman of the Noxious Weed Control Board to act as the Chairman in his absence. Roll Call: Ayes: Gans, Fritsche. Abstain: Dean.
