BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

January 26, 2026

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on January 26, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by Fritsche, to add "approve Resolution No. 1587, Book 24, Page 94 to the consent agenda. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. Tracy Soderlund was present to observe. Sheriff Darling updated the Board. They have become an Accredited Agency; a sheriff's app is now available on smart phones. They have new body armor, new vehicles, and have added MACH and TraX to their systems. The deputies have all completed TIM training. The office has updated all policies, including new job descriptions, and has purged old files.

There were no issues for the Board of Equalization.

A motion was made by Dean, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$485,846.22, 3) reappoint Misti Soderlund to the Health Board, term to expire February 28, 2029, 4) Resolution No. 1587, Book 24, Page 94 to allow the Treasurer to advertise delinquent taxes. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to enter a public hearing to amend the budget for Household Hazardous Waste at 9:30 a.m. Roll Call: Ayes: Gans, Dean, Fritsche

Gans explained the budget overage in Household Hazardous Waste. There was an excess amount placed in reserves, and not enough in budget authority. The resolution will move \$150,000 from reserves to spendable authority.

A motion was made by Dean, seconded by Fritsche, to exit the public hearing. Roll Call: Ayes: Gans, Dean, Fritsche

A motion was made by Dean, seconded by Fritsche, to approve Resolution No. 1588, Book 24 Page 95 to amend the budget for Household Hazardous Waste. Roll Call: Ayes: Gans, Dean, Fritsche

At 9:45 a.m., Elizabeth Aguirre joined the Board meeting to discuss her interest in being the Tourism Director.

A motion was made by Fritsche, seconded by Dean, to appoint Elizabeth Aguirre as Tourism Director for 2026. Roll Call: Ayes: Gans, Dean, Fritsche.

Kasey Taylor and Ron Soden joined the Board at 10:00 a.m. to discuss their interest in being the County Noxious Weed Superintendent.

Gans reviewed the qualifications for the position, and the County's expectations from the successful applicant.

A motion was made by Gans to appoint Kasey Taylor as Noxious Weed Superintendent. Motion died for lack of a second.

A motion was made by Dean, seconded by Fritsche, to appoint Ron Soden as Noxious Weed Superintendent for 2026. Roll Call: Gans, Dean, Fritsche.

The Board reviewed quotes received for an auditor for the 2025-2026 fiscal year. A motion was made by Dean, seconded by Fritsche, to contract with Countryman to audit the County's records and procedures for the fiscal year 2025-2026. Roll Call: Gans, Dean, Fritsche.
