

BOARD OF COMMISSIONERS, BOARD OF EQUALIZATION, AND NOXIOUS WEED AUTHORITY

February 23, 2026

The Red Willow County Board of Commissioners, Board of Equalization and the Noxious Weed Authority met in the Commissioners' Room in the courthouse on February 23, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. Melanie Knight, a District 38 hopeful, introduced herself to the Board. Knight is from Clay Center and understands funding difficulties.

Gans recessed the meeting at 9:12 a.m. for the Board of Equalization.

Chairman Dean called the Board of Equalization to order at 9:12 a.m. with the following members present: Commissioners Ted Gans, Randy Dean, and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

A motion was made by Gans, seconded by Fritsche, to recess the regular meeting and enter into a public hearing at 9:15 a.m. Roll Call: Ayes: Gans, Dean, Fritsche.

Lori Stevens, Assessor, presented permissive exemptions.

A motion was made by Gans, seconded by Fritsche to adjourn the public hearing at 9:17 a.m. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Gans, seconded by Fritsche, to approve the exemptions as recommended by the Assessor. Roll call: Ayes: Gans, Dean, Fritsche. Dean adjourned the Board of Equalization at 9:19 a.m.

At 9:26 a.m. Chairman Fritsche called the Noxious Weed Control Authority meeting to order with the following members present: Commissioners Ted Gans, Randy Dean, and Charles Fritsche. Fritsche informed the public about the location of the posted Open Meetings Act.
