

BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

June 22, 2026

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on June 22, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. Brent Niese and Matt Bright from Summit Carbon Solutions were present to introduce themselves and explain a proposed pipeline that would carry CO₂ from ethanol plants for utilization of carbonless energy.

Chairman Gans recessed the Board of Commissioners meeting for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:13 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Lori Stevens, Assessor, presented Tax Roll Correction No. 7 from 2025 for a total increase of \$5.62.

A motion was made by Gans, seconded by Fritsche, to approve the tax roll correction as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:16 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:16 a.m.

Judge Patrick Heng joined the Board to discuss a new Bailiff Agreement. The current one ends June 30, 2026.

A motion was made by Dean, seconded by Fritsche, to approve the agreement as presented, assuming the participation of the other counties. Roll Call: Ayes: Gans, Dean, Fritsche.

There were no gravel bids presented.

The following reports were reviewed and placed on file: Clerk's and Sheriff's monthly revenue reports.

A motion was made by Dean, seconded by Fritsche, to enter a public hearing at 9:45 a.m. to open the budget for the purpose of amending budget authority. Roll Call: Ayes: Gans, Dean, Fritsche.

The resolutions presented will amend Budget Authority only and will not affect tax monies collected. Authority will be transferred from Inheritance Tax to the General Fund, and then to the Self-Insurance Fund to cover higher than expected medical claims this fiscal year.

A motion was made by Dean, seconded by Fritsche, to exit the public hearing. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to approve Resolutions No. 1592, 1593, 1594 and 1595, Book 24 Pages 99, 100, 101 and 102 to amend the budget for General, Self-Insurance and Inheritance Tax Funds. Roll Call: Ayes: Gans, Dean, Fritsche.

The Board discussed opening the Time Capsule buried in front of the Courthouse. A motion was made by Dean, seconded by Fritsche, that with the agreement of the Mayor, the Chamber of Commerce, and the Museum, the capsule will be opened during Heritage Days in September. The objects removed will be displayed at the Museum. Roll Call: Ayes: Gans, Dean, Fritsche.

The Board worked on County budgets.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$637,344.97, 3) agreement with Daniel D. Miller, CPA for 2026/2027 Budget preparation, 4) Resolution No. 1591, Book 24, Page 98 to Transfer Budget Authority between Functions in the General Fund. Roll call: Ayes: Gans, Dean, Fritsche.
