

BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

July 13, 2026

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on July 13, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:33 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

Mike Huizenga from Great Plains Towers LLC was present to answer any questions. Bill and Julie Ellis own the land where the tower will be built, possibly in late 2026.

Donna Goad with Domestic Abuse/Sexual Assault Services was present to request support for fiscal year 2026/2027. Like everyone else, they have budget problems.

A motion was made by Dean, seconded by Fritsche, to continue support in the amount of \$10,601.00 for the 2026/2027 fiscal year. Roll call: Ayes: Gans, Dean, Fritsche.

Jon Cannon, NACO Executive Director, joined the Board to update them on several Legislative changes either already in effect, or being implemented in the near future.

Joyce Anderson with the McCook Humane Society was present to request support for fiscal year 2026/2027. They have gotten away from relying on volunteers to minimum wage part-time employees.

A motion was made by dean, seconded by Fritsche, to continue support in the amount of \$450.00 per month for the 2026/2027 fiscal year. Roll call: Ayes: Gans, Dean, Fritsche.

Rose Weskamp joined the Board to recommend a recovery center that could be supported, in part, by the County's Opioid Fund.

The Board worked on the County's budget.
