

BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

July 27, 2026

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on July 27, 2026. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 8:30 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

Clerk Cooper asked the Board to add an item to the Consent Agenda: Resolution 1601, Book 24, Page 108, to transfer \$750,000.00 as needed from the Inheritance Tax Fund 2700 to the General Fund 0100.

A motion was made by Dean, seconded by Fritsche, to approve the addition of that item. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as amended. Roll call: Ayes: Gans, Dean, Fritsche.

The Board reviewed accounts payable and payroll claims.

At 9:00 a.m. Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$491,115.82, 3) Special Designated Liquor License for Hurling Hatchets LLC, 4) Road Occupancy Permit for McCook Public Power District, 5) Resolution 1601, Book 24, Page 108, to transfer \$750,000.00 as needed from the Inheritance Tax Fund 2700 to the General Fund 0100. Roll call: Ayes: Gans, Dean, Fritsche.

The following reports were reviewed and placed on file: 1) Household Hazardous Waste Quarterly Report, 2) Treasurer's Semi-Annual Report, 3) Sheriff's Monthly Revenue Report.

The Board reviewed an Invitation to Participate from the Nebraska Department of Roads.

Chairman Gans recessed the Board of Commissioners meeting for the Board of Equalization.

BOARD OF EQUALIZATION MEETING:

Chairman Randy Dean called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Lori Stevens, Assessor, presented a homestead exemption application that missed the deadline, but was submitted in time for the Board's review.

A motion was made by Gans, seconded by Fritsche, to approve the request as presented. Roll Call: Ayes: Gans, Dean, Fritsche.

Stevens presented the annual report on cemetery ownership within the County. There are still nineteen cemeteries in the county, with no change of ownership.

Stevens also presented her three-year plan of assessment as well as tax roll correction No. 8 for 2026. A motion was made by Gans, seconded by Fritsche, to approve the correction for an increase of \$364.10. Roll Call: Ayes: Gans, Dean, Fritsche.

Chairman Dean adjourned the Board of Equalization meeting at 9:22 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:22 a.m.

The Board discussed County Zoning issues. Matt Bright with Carbon Solution was present to give the Board more information on the possibility of a pipeline in the north part of the County.

John Rundel with Southwest Weed Management joined the Board to request support for the 2026/2027 fiscal year. He requested a letter of support as well as a \$500.00 contribution.

A motion was made by Dean, seconded by Fritsche, to issue a letter of support and contribute \$500.00 to Southwest Weed Management. Roll call: Ayes: Gans, Dean, Fritsche.

Ryan Wilcox, the County's current Public Defender, spoke to the Board about his upcoming retirement. Wilcox plans to retire May 31, 2027. He recommended that the Board put together a Public

Defender Qualifying Commission to search and interview attorneys. Wilcox believes it will be difficult to find someone to take on the position.

Sheriff Dalton Downing presented the Sheriff's Report of Uncollected Distress Warrants. Out of a beginning total of \$261,505.64, Downing has managed to collect all but \$13,966.54.

The Board worked on the County's budget with the assistance of Dan Miller, CPA.

A motion was made by Dean, seconded by Fritsche, to enter Executive Session for the prevention of needless injury to the reputation of an individual.

A motion was made by Dean, seconded by Fritsche, to exit Executive Session.
